2. Approval of Agenda

3. Review and Approval of the minutes from June 10, 2013

 Minutes for the March 12th, May 15th and June 10th have all been approved and will be added to the website

4. Article 22.5(a) Regular Appointments: Competition for Auxiliary Appointments (K. Whitehouse)

- As outlined in Article 22.5(a) Employees on regular appointments and not on probation may apply for a
 posted auxiliary appointment of four consecutive months or more. If an employee on a regular
 appointment is the successful applicant, assignment to the auxiliary position shall be subject to the
 availability of a suitable replacement in accordance with Clause 16.2(c). For the duration of the
 assignment, such employee shall retain regular appointment status and shall return to his/her original
 position upon completion of the project and/or assignment period.
- Recently an employee applied for a 1 year LOA without pay to pursue a year Auxiliary placement in another department, they were the successful candidate, but was then verbally denied the leave due to the affect it would have on the current department. The employee then resigned from their current position to accept the new auxiliary position.
- For any type of future case, have it brought to the attention of the Human Resources department to
 understand from the beginning and review and discuss rational. HR could then recommend for
 individual to discuss with the Union rep to understand any type of personal consequence (benefits,
 pension, seniority, etc.) and possibly prevent an employee from resigning from their position.
- The employee is not seeking any type of resolution

5. Book Store JD's going to the JJEC (K. Whitehouse)

- Carry forward to next meeting

6. Workshop & Guest Speaker re Interest Based Bargaining (P.Brandes)
